***Please observe the instructions for the storage of hazardous goods containers.**

1. Calculation principles of loading units in storage at the inland rail terminal

- **The ERS terminal terms and conditions are valid from 01.01.2024, subject to change during the year. All information is without guarantee.**
- The capacities for interim storage at the inland rail terminal are limited.
- **Special note on dangerous goods containers:**
 - Dangerous goods containers may be delivered to the terminal at the earliest on the day of the train's departure or collected from the inland rail terminal within the opening hours on the day of the train's arrival. The temporary storage of loading units with dangerous goods is limited to 24 hours.
 - After 24 hours, penalty surcharges apply. These costs will be charged in addition to the storage costs (see individual terminal conditions, sections 2. to 10.), handling fees and any transfer costs.
 - The free storage time granted by the terminal starts with the arrival of the train and / or from the time the container enters the inland rail terminal and ends with the departure of the container and / or the departure of the train from the inland rail terminal.
- The storage fee is calculated on the basis of calendar days.
- Loading units received on national public holidays are charged as the loading units are received on the following working day.
- Any storage fees incurred will be charged in accordance with these terminal terms and conditions, even without a notification. This applies both to storage charges incurred during the transport as scheduled and to those resulting from changes to the initial scheduled transport.
- Storage fees are generally invoiced in the month following the completion of the transport.
- At peak times, the terminals may declare acceptance stops. The customer must bear all costs incurred as a result of such an acceptance stops, e.g. for return transport (evacuations). Any additional storage / handling charges incurred will be invoiced.

The following also applies to import loading units:

- After expiry of the free storage time granted by the terminals, the conditions listed per terminal apply to empty and laden units in transport related storage.
- The terminals can set a time limit for temporary storage. If the deadline is exceeded, the container will be transferred to a separate storage area. ERS will invoice the customer for the additional costs incurred for the "transfer to the separate storage area".

The following also applies to export loading units:

- The options and conditions for short-term storage depend on the inland terminal. The following options currently apply:
 - The delivery of containers is only possible within the storage-free period.
 - Containers can be delivered before the storage-free period, storage fees apply
 - The delivery of containers before the storage-free period is only possible in separate storage areas, additional charges apply.
- If loading units are delivered to the terminal before the permitted time specified by the terminal, the loading units are moved to a separate storage area in the respective terminals and returned to the terminal shortly before loading. For this process, the customer must pay ERS an additional fee for shunting in accordance with the display. The delivery and interim storage of containers is always subject to capacity.
- ERS reserves the right in all inland rail terminals to transfer loading units to a nearby storage location and / or depot (section 11. Storage / interim storage outside the inland rail terminals (incl. transfer for rail shipment), in particular in the event of capacity bottlenecks in the inland rail terminals).

12. Handling charges / storage charges seaport

12.1. Handling seaport

If the loading unit is picked up or delivered by the customer at the seaport terminal, additional handling fees will be charged according to the table below (handling fees & dangerous goods surcharge per movement). These fees apply during the storage fee-free period at the seaport rail terminals. If storage charges are incurred, we may charge an additional handling fee. The storage fees can be found in section 12.2 Storage fees in the seaport.

If the loading unit has already been picked up / delivered and must be picked up / delivered again (handling truck - terminal - truck), the handling costs deviate from the conditions stated below. These costs are calculated according to the delivery.

Any additional handling will be charged in accordance with these terminal terms and conditions, even without an advice note.

12.2. Storage charges in the seaport

If the loading units are not delivered or collected within the free storage time granted, the customer must pay the storage fee **according to the table below** in the seaports of Hamburg, Bremerhaven, Wilhelmshaven and Rotterdam. The free storage time varies depending on the sea terminal.

The customer must deliver the import loading units to the rail terminal one working day before the confirmed departure of the train.

For the seaport of Rotterdam, the storage of dangerous goods is limited to a maximum of 13 days. After that, the terminal can transfer the loading unit with the dangerous goods to a separate storage area. The customer shall bear all resulting costs as per disbursement. ERS shall not be liable for any damage / costs incurred by the customer due to the delayed collection of the loading unit.

Any storage charges incurred shall be invoiced in accordance with these terminal terms and conditions, even without notification. This applies both to storage charges incurred during the transport as scheduled and to those resulting from changes to the initial transport schedule. As a rule, storage charges are invoiced in the month following the completion of transportation.
